1. FOOD TICKETS

The event will sell Taste Tickets at designated ticket booths.

All participating restaurants are required to accept Taste Tickets as payment for their food items. Cash transactions and free food sampling are prohibited. Food Tickets will be valued at \$1 per ticket. Restaurants must collect Taste Tickets for all food sales at their booth and turn them into a designated event representative.

2. FOOD PRICING AND TASTE TICKET REDEMPTION

HOW WILL FOOD BE PREPARED? (Check all that apply)

Restaurants are encouraged to provide 1 to 3 sample-sized items for sale.

Sample-sized portions should be 1 to 3 oz. in size to encourage patrons to try various items at the festival.

Items must be priced at 2, 3, 4, or 5 Taste Tickets, equivalent to a \$2 to \$5 item value.

An event menu with ticket prices should be prominently displayed.

Prices may not be altered during the event.

After the event, all participating restaurants must turn in all Taste Tickets collected during the event to designated event representatives.

Vendors who fail to turn in Taste Tickets on the day of the event will forfeit their revenue share.

3. TASTE TICKET COLLECTION, OPTIONAL REVENUE SHARE, AND BOOTH LOCATION

Event coordinators will count collected tickets.

Restaurants may elect to receive a check (issued 10-14 days following the event) for 50% of the value of Taste Tickets collected at their booth after the event.

Restaurants electing to contribute 100% of their collected Taste Tickets to support Taste of Lilburn beneficiaries will be considered VIP RESTAURANTS. Upon receipt of their application, they will have the opportunity to select their table location in the event location on a first-come, first-served basis.

Event organizers will assign locations for all other restaurants.

4. BEVERAGES

Food vendors and their staff are prohibited from consuming or selling alcoholic beverages. All beverages, except for approved specialty drinks, shall be sold exclusively by Taste of Lilburn.

5. VENDOR AREA

Your restaurant will be provided a table space in Parkview High School Cafeteria.

Table location assignments will be made approximately ten (10) days prior to the event.

Restaurants must provide tablecloths (if desired), signage, and any table décor.

Optionally, restaurants can request power to their booth, first come first serve.

6. PROMOTIONAL MATERIALS

Restaurants are encouraged to make menus and coupons available to the public following the event to encourage patronage.

Vendors should also hold drawings and/or provide promotional giveaways at their booth--such as coupons, gift certificates, etc.-- to promote their restaurant and increase patronage.

7. Taste of Lilburn is a family-oriented community event, and all exhibits must be designed, constructed, and operated in good taste with the best interest of the event and public safety.

No explosive fuels or other highly combustible matter will be permitted.

Carnival tactics, using public address systems, or other similar activities by the Vendor are not allowed. Taste of Lilburn does not guarantee the exclusivity of the products displayed.

8. EVENT HOURS

Because each event attendee should have the right to see all the exhibits, no exhibit or table may be closed during the event hours or dismantled/removed until the event ends.

The event starts promptly at 4:00 p.m., and all restaurants are expected to be fully set up and operational by then.

The event officially ends at 7:00 p.m., and restaurants are expected to remain open and serve food until then.

After 7:00 pm, restaurants may elect to start breaking down/packing up booths even if the event is to run over its designated time. You must be clear of the building by 8 pm.

Vendors who do not set up on schedule may have their designated space changed or occupied by another vendor at the discretion of event coordinators.

Vendors will be welcome to unload and set up from 2:45 to 3:45. **Anyone arriving after 3:45 will be turned away.**

9. CANCELLATION

If any Vendor elects to cancel the contracted space for any reason, they should notify the Taste of Lilburn Coordinator within 48 hours of the event.

10. CLEANLINESS, DAMAGES & TRASH

Vendors are responsible for maintaining acceptable sanitation standards within their booths and for disposing of trash in trash receptacles provided by Taste of Lilburn.

Vendors are responsible for cleaning their assigned area of all debris, grease, and soot at the event conclusion.

Any vendor that leaves their space damaged, unclean, or stained shall be assessed a damage/cleaning fee.

Vendors using grease in their operations or producing grease waste or wastewater as by-product of their food preparation must not dispose of their grease and wastewater on the event site.

Any such materials will need to be removed from the event site and taken back to your restaurant for appropriate disposal.

If Vendor is found to improperly dispose of wastewater or grease on the event site, a \$500 fee will be charged to Vendor.

11. BEST OF AWARDS

The restaurant that collects the most Taste Tickets receives the coveted "People's Choice Award."

12. ELECTRICITY

Power will be provided in certain areas.

Restaurant vendors are encouraged to use means other than electricity to prepare food. Please note: no grills allowed inside the building.

If the Vendor requires additional power, the electricity request must be recorded on this contract and turned in no later than February 1st for booth placement within close proximity of power plugs and to assure power is available to accommodate everyone's needs.

13. LIABILITY

All Vendors shall, at their own expense, provide Public Liability coverage for their own operation, and it shall be

their responsibility to present an event with evidence of Bodily Injury and Property Damage coverage of no less than \$1,000,000 combined single limit for Bodily Injury and Property Damage.

A vendor shall not be allowed to set up without a Certificate of Insurance on file naming Taste of Lilburn, GFWC Lilburn Woman's Club, and Parkview High School as "ADDITIONAL INSURED."

Certificates of insurance shall be mailed to the event by February 16, 2026.

14. LIABILITY WAIVER AND RELEASE

I assume all responsibility for, and risks and hazards of, participation in the rental activity planned by my group. I, and all members of my group, do hereby release Taste of Lilburn, GFWC Lilburn Woman's Club and Parkview High School, including all officials, officers, employees, sponsors, organizers, supervisors, volunteers, participants, and all other agents, of any and all claims, demands, rights, and causes of action of whatever kind and nature, arising from and by reason of, and all known and unknown, foreseen and unforeseen, bodily and personal injuries, damage to property, and the consequences thereof, resulting from participation in the activity planned by GFWC Lilburn Woman's Club and Taste of Lilburn.

I hereby make an application for booth space for March 7, 2026, Taste of Lilburn event. Having done so I agree to abide by the rules and regulations provided with this application. I further understand that failure to abide by said rules and regulations will result in my being removed from the event.

Additionally, I will not be invited nor included in future shows sponsored by said committee. I understand that neither the GFWC Lilburn Woman's Club nor Parkview High School nor any person(s) associated therewith are responsible for loss or damage of work, personal injuries, or property damage, nor will the artist/exhibitor be a party to legal action against them, nor against any property owner with whom the exhibitor comes in contact. If an exhibitor is asked to leave the show for failure to abide by said rules and regulations previously set forth in the application, no fee is refundable. I have read and understand the above.
